4. PHYSICAL AND SAFETY DATA Fineliner pen containing an odourless water-based dye-ink Robust metal-encased plastic tip. Ideal for working with rulers and stencils. Hexagonal orange casing with white edge-stripes. Ventilated cap and sealed end-cap in the shade of the ink. 25 brilliant colours. Not intended for use on the skin. When stored and used properly, no hazardous reactions can be expected. In case of fire, carbon monoxide (CO), carbon dioxide (CO ₂) and with some colours nitric oxides (NO _x) will be set free as thermal decomposition products. When not used properly, some colours may stain the skin, mucous membranes or clothing and fabrics. In some materials, the stain might be permanent. In case of contact with the eyes, rinse out open eye thoroughly under running water for several minutes. If complaints persist, contact an ophthalmologist. Based on the EEC-Directive 91/155, this commercial product is not a hazardous substance, hazardous mixture or a particular product with respect to the German Regulation on Dangerous Substances (Gefahrstoff-Verordnung). 5. TRANSPORT INFORMATION Not classified as dangerous goods with respect to the transport regulations.
6. ECOLOGICAL INFORMATION / DISPOSAL CONSIDERATIONS The casing, cap consist of polypropylene. If recycling is not possible, the writing instruments may be added to the household waste in small quantities. Larger quantities are to be disposed of under compliance with local public authority regulations, e.g. at a suitable waste disposal site or incinerator. Only small quantities of dyes are contained in the inks. They are, however, very durable-on account of their intended use and therefore biodegradability in normal conditions in sewage works or in surface waters is difficult. They can, however, be sufficiently adsorbed in the activated sludge and eliminated from the water.
